**Notice of Destruction of Noxious Weeds**

To All Property Owners in Poweshiek County, IA

You are hereby notified that in accordance with the provisions of Chapter 317 of the Code of Iowa and amendments thereto, the Board of Supervisors and the appointed Weed Commissioner of Poweshiek County, Iowa declare that owners or persons in control of real estate within said county should destroy all weeds declared, "noxious" by the Iowa Department of Agriculture and Land Stewardship that exist on real estate within Poweshiek County, Iowa.

The following species of, "noxious" weeds shall be destroyed by landowners in Poweshiek County, Iowa **before the 15th of May and as often as necessary thereafter to prevent seed production and spread.**

<i>-Musk Thistle</i>	<i>-Curled (Sour) Dock</i>	<i>-Leafy Spurge</i>	<i>-Common Teasel</i>
<i>-Red (Sheep) Sorrel</i>	<i>-Smooth (Pale) Dock</i>	<i>-Quackgrass</i>	
<i>-Buckthorn</i>	<i>-Perennial Pepper Grass</i>	<i>-Multiflora Rose</i>	

The following species of, "noxious" weeds shall be destroyed by landowners in Poweshiek County, Iowa **before the 15<sup>th</sup> of June and as often as necessary thereafter to prevent seed production and spread.**

<i>-Canada Thistle</i>	<i>-Russian Knapweed</i>
<i>-Buckhorn Plantain</i>	<i>-Wild Mustard</i>

The following species of, "noxious" weeds shall be destroyed by landowners in Poweshiek County, Iowa **before the 15<sup>th</sup> of July and as often as necessary thereafter to prevent seed production and spread.**

<i>-Field Bindweed</i>	<i>-Horse Nettle</i>	<i>-Velvetleaf</i>	<i>-Wild Carrot</i>
<i>-Poison Hemlock</i>	<i>-Perennial Sow thistle</i>	<i>-Wild Sunflower</i>	<i>-Puncturevine</i>

The following "invasive" species shall be added to the Poweshiek County list of noxious weeds and should be sprayed, or otherwise controlled whenever they are found on lands in Poweshiek County, Iowa.

- Phragmites (reed grass)*
- Garlic Mustard*
- Japanese Knotweed*
- Marijuana*

In case of landowners and tenants failing to comply with an order to destroy weeds made pursuant to Chapter 317, the Weed Commissioner or Deputies assigned by the Weed Commissioner may enter private lands five days after serving a destruction notice in order to conduct control on any weed infestation. The cost of this destruction, plus a 25 percent on the dollar fine shall be billed to the landowner. If the bill is not paid, the cost of said destruction will be assessed to the tax roles of the weed violator. Also, the weed commissioner may pose a fine for each day of non-compliance up to ten days at the rate of ten dollars per day.
