RESOLUTION #2928

Notice of Destruction of Noxious Weeds

To All Property Owners in Poweshiek County, IA

You are hereby notified that in accordance with the provisions of Chapter 317 of the Code of Iowa and amendments thereto, the Board of Supervisors and the appointed Weed Commissioner of Poweshiek County, Iowa declare that owners or persons in control of real estate within said county should destroy all weeds declared, "noxious" by the Iowa Department of Agriculture and Land Stewardship that exist on real estate within Poweshiek County, Iowa.

The following species of, "noxious" weeds shall be destroyed by landowners in Poweshiek County, Iowa **before the 15th of May and as often as necessary thereafter to prevent seed production and spread.**

The following "invasive" species shall be added to the Poweshiek County list of noxious weeds and should be sprayed, or otherwise controlled whenever they are found on lands in Poweshiek County, Iowa.

- Phragmites (reed grass)*
- Garlic Mustard*
- Japanese Knotweed*
- Marijuana*

In case of landowners and tenants failing to comply with an order to destroy weeds made pursuant to Chapter 317, the Weed Commissioner or Deputies assigned by the Weed Commissioner may enter private lands five days after serving a destruction notice in order to conduct control on any weed infestation. The cost of this destruction, plus a 25 percent on the dollar fine shall be billed to the landowner. If the bill is not paid, the cost of said destruction will be assessed to the tax roles of the weed violator. Also, the weed commissioner may pose a fine for each day of non-compliance up to ten days at the rate of ten dollars per day.

The Board met in regular session at 8:30 a.m. Members present: Larry Wilson, Trevor White and Lamoyne Gaard.

Larry led the Pledge of Allegiance to the Flag.

8:30 a.m. Moved by White, 2nd by Gaard to enter into a public hearing to receive comments for or against an amendment to the FY'16 Poweshiek County budget. Wilson-aye. White-aye. Gaard-aye. Motion carried. Present: Supervisors Larry Wilson, Trevor White, Lamoyne Gaard and Auditor Diana Dawley. The Auditor reviewed changes to FY'16 departmental appropriations. There was no one present to speak for or against the amendment. The Supervisors discussed increases in Public Safety, Mental Health and Elections. 8:48 a.m. Moved by White, 2nd by Gaard to authorize Larry Wilson, Chairman to sign Record of Hearing and Determination on the Amendment to the FY'16 County budget along with Resolution #2930 to make changes in the FY'16 departmental appropriations. Wilson-aye. White-aye. Gaard-aye. Motion carried. The Chairman certifies that proof of publication of the hearing notice and proposed amendment is on file in the Auditor's office. All notices were published not less than 10 or more than 20 days prior to the public hearing, and that adopted expenditures do not exceed published amounts for any of the 10 individual expenditure classes, or in total. The meeting was electronically recorded.

Moved by White, 2nd by Gaard to accept with regret the resignation of Larry Austin, Secondary road department effective April 22, 2016. 3 ayes. Motion carried.

Moved by Gaard, 2nd by White to approve Utility permit #16-20U to Interstate Power & Light for work in Section 4, Pleasant township. 3 ayes. Motion carried.

The Poweshiek County Board of Supervisors met Monday, March 14th, 2016 at 9:00 A.M in the Poweshiek County Courthouse Board of Supervisors meeting room to hold a public hearing. The meeting was recorded and on file in the office of the Poweshiek County Zoning Administrator.

At 9:00 A.M., Trevor moved to open the public hearing. Lamoyne 2nd. All in favor

Chairman Wilson turned the floor over to Zoning Administrator J.D. Griffith. Trevor White asked about the driveway situation as he was familiar with the driveways in the area. Chris stated that he did have an approved driveway from Poweshiek County, but a new driveway would require 200' of Poweshiek Water to be lowered and a significant amount of dirt moved. He was working with the buyer on a shared driveway to allow using Chris' existing driveway.

J.D. Griffith, Sanitarian/Zoning Administrator presented the FY'16 Sanitarians Report for February 2016. Discussion followed regarding septic testing, water testing, and revision of Zoning fees relating to wind turbines.

10:00 a.m. Moved by Gaard, 2nd by White to enter into a public hearing regarding the construction application for a swine confinement feeding operation in the name of Siraj Thomason, SE1/4 SE1/4, Section 26, Scott township. 3 ayes. Motion carried. Present: Angie Cook, Sara & Dennis Youngkin, Robert Hagerty, Bill Armstrong, Robert McLain, Barb & Tom VanErsvelde, Brian Ritland, Pinnacle; Siraj Thomason, Eric Thomason, Donna Winburn, Jean Perri, James McNaul, L.B. Sherman, Val Vetter and Duane McDonald. Chairman Wilson started the meeting by discussing procedure for the meeting, discussed location and distances from the proposed confinement to houses in the neighborhood. Larry stated the Board had received the Manure Management Plan on February 22, 2016. Siraj Thomason explained he had acquired three acres from his grandmother to build the confinement and felt it was a great way to get back to the farm because it provided a job opportunity for him to make a living. Larry read an email letter from Mark A. Johnston, 10005 Covington Dr SE, Huntsville, AL stating his concerns that any final approval of the confinement would greatly devalue his property, negatively impact the air quality, water and soil quality of his property. Discussion followed regarding animal units, responsibility of the DNR to monitor by doing site checks, lack of air quality checks, and cost of County road maintenance. Angie Watson-Cook, Attorney read a letter from John and Richard Fitzsimmons, owners of Fitzsimmons Farm LLC. This letter spoke of concerns regarding run off, maintenance of County roads, farm ponds to the north and south, tributaries affected, odors and increased dust. Discussion continued regarding use of bio-filters and methane digesters, taxation of buildings and advantages of having young farmers moving back to the area. 11:02 a.m. Moved by Gaard, 2nd by White to adjourn. 3 ayes. Motion carried.

11:06 a.m. Lana Taylor discussed questions regarding a proposed shooting range at the Poweshiek County landfill farm. Discussion of safety concerns, construction of berms, whether it would be for trap, Skeet, Bunker, pistol, or low caliber long rifle, DNR qualified coaches, and liability.
