Resolution 2023-31

A RESOLUTION TO APPROVE DISBURSEMENT OF FUNDS FOR THE AMERICAN RESCUE PLAN ACT.

WHEREAS, on March 11, 2021, President Biden signed the 109 trillion-dollar American Rescue Plan Act and,

WHEREAS, Poweshiek County applied for and was awarded American Rescue Plan Act funds totaling \$3,594,185.

WHEREAS, pursuant to Interim Final Rule, Poweshiek County allocated a portion of the American Rescue Plan Act funds as government services.

WHEREAS, the Poweshiek County Board of Supervisors approved use of the funds allocated for government services be applied toward radio tower site locations.

WHEREAS, the south tower site will be located on land owned by Poweshiek County in a part of Government Lot 2, Section 2, Jackson Township.

WHEREAS, said land was originally purchased by Poweshiek County using Iowa DNR REAP funds and as such other land had to be acquired to mitigate for this land where the tower is to be located.

WHEREAS, Poweshiek County Conservation entered into a land acquisition and the Board of Supervisors agreed to pay \$13,500, which was ¼ of the purchase price for said land in order to mitigate for the approximate acre of land utilized for the tower site, which was paid with Iowa DNR REAP funds.

WHEREAS, Poweshiek County Conservation paid the land purchase from their fund and the \$13,500 should be reimbursed to that fund.

BE IT RESOLVED that the Poweshiek County Board of Supervisors endorses the disbursement of American Rescue Plan Act Funds for the item listed and authorizes the Auditor to make payment to Poweshiek County Conservation REAP fund for \$13,500 for land acquisition, a portion used to mitigate for the land where the tower will be located, which was paid with Iowa DNR REAP funds.

Tindle stated he attended the Poweshiek County Conservation Board meeting.

8:47 a.m. Lyle Brehm, Engineer joined the meeting.

8:50 a.m. Kevin Nagel and Brian Edelen met with board to discuss 80th Street between Hwy 6 and 370th Avenue. Nagel wanted to discuss the past, present, and future of this stretch of road. Roudabush stated this section of road is a highly traveled road and this road is being utilized by contractors hauling dirt from a building project by Grinnell College. Brehm stated he reached out to the college about the damage this hauling is doing to the road. The college made an agreement with the contractor to work with county on providing rock to this stretch of road sharing in the cost. Brehm stated that all rock roads are maintained the same whether farm-to-market or not and the cost to maintain a rock road is approximately \$5,000-\$6,000 per mile per year. Brehm stated he has a few options available for proposed work on this section of road. Brehm stated this is on his plan for this year to address the issues. Edelen inquired if anything was on plan to help the drainage issue. Edelen inquired if more contract rock hauling will be done this year. Brehm stated he has been utilizing contract rock hauling for many years. Roudabush stated this is a highly traveled road and the county is committed to building up this road and creating a better base.

Brehm presented the board with a draft of a job description for roadside manager. Board will review and approve this at a future board meeting.
