Brehm presented to the board a draft job description for roadside manager position. Board reviewed the job description and determined it to be acceptable. Brehm stated he was not sure on the pay range for this position and would need to research that further. Brehm stated he is looking to hire a roadside manager, who will also be appointed as weed commissioner, and also to assist with secondary road duties. Brehm will present back to the board once he has determined the pay range.
