Watson discussed her concerns regarding the raises of county employees and feels the 11% and 15% is too much and noted teachers are only getting 3% and also the small businesses are concerned and feels everyone wants to work for the county. Watson stated State of Iowa elected officials have not been receiving raises, so why such big raises for county employees? Watson stated she is in favor of the property tax reform and the proposed caps, which is currently being discussed in State of Iowa Legislature.

Roudabush stated wages of other counties and like positions are looked at each year and it was determined that Poweshiek County was below average and pay needed to be increased. Dawley stated the compensation board representing the elected officials recommended an 11% increase and Dawley stated the county can't compete with area employers, such as Grinnell Mutual and City of Grinnell. Tindle stated it is hard to get and keep good

employees because they can go elsewhere and make more money. Further discussion among public present expressing their concerns with taxpayer dollars and wages of county employees.

Roorda asked how much money the county was receiving from the wind turbines. Board stated the county is currently receiving tax income. Roorda stated that if receiving income from the turbines, why were two bridges by his confinements embargoed and now he must find an alternate route to haul from his confinement, costing him more. Tindle stated the county is starting to get in the TIF money from the turbines and rural rock road system is on the list for projects with this money.
