## BOARD OF SUPERVISORS/ZONING PUBLIC HEARING MINUTES

The Poweshiek County Board of Supervisors met August 31<sup>st</sup> 2023 at 9:00 AM in the Boardroom of the Poweshiek County Courthouse. The meeting was recorded and on file in the office of the Poweshiek County Zoning Administrator.

Roll Call: Supervisors – Jeff Tindle, Jason Roudabush, and Diana Dawley, Auditor's Office – Laura Tish, Zoning Administrator J.D. Griffith, Todd Ahrens, Kevin L. Smith, Kevin M. and Heidi Smith, Tom & Carol Hirsch, Lorella Nagel.

At 9:00 AM Diana made a motion to open Public Hearing, Jeff second, all in favor, motion carried.

J.D. Griffith stated the Zoning Commission met on August 29<sup>th</sup> 2023. The Zoning Commission voted 4-0 in favor of recommending approval, but recommended installing a stipulation that no lots could be sold until a DNR Storm Water discharge permit was obtained and permitted.

Todd Ahrens is requesting a change in Zoning of 2 acres m/l from Agriculture to Lake Area Residential for the purpose of selling lots to adjacent property owners on Horseshoe Dr. The proposed Zoning change is located in Section 4 T-78-N R-15-W known as Gov Lot 1 N 30.35 AC Uneven Width EX Horseshoe Timber Plat 1 with 23.5 AC Forest Reserve. The proposed change is located approximately 1000' south of 480<sup>th</sup> Ave and 200 Ft. North of North Dr. and extends approximately 800' East of North Dr.

Todd stated that he wanted to sell the lots as is, and no work was going to be done, so no Storm Water permit could be obtained as he wasn't doing any earth moving.

Tom Hirsch stated that there is a possibility of 12 buildings going up, so the permit should be obtained for that purpose.

Kevin M. Smith asked if this was part of a bigger plan, starting with the furthest away and then the whole hillside would eventually be developed. Todd stated that was not the intent as they did not have any plans of selling anything else.

Talks continued about Water runoff for some time, why Lake Area Residential, whether people could live there, and Horseshoe Timber Plat 1 runoff.

Diana, Jason, and Jeff asked questions pertaining to Stormwater permits, the site, and General Zoning questions. At 9:26 A.M., Jeff made a motion to go out of the public hearing. Diana 2<sup>nd</sup>. All in favor, motion carried. Diana made a motion to table the request so all three Board Members could go out and view the property. Jeff 2<sup>nd</sup>. All in favor, motion carried. A meeting to act on the request was set for September 11<sup>th</sup>, 2023 at 9:00 A.M. J.D. Griffith, Poweshiek County Zoning Administrator
