CERTIFICATION (CANVASS) OF PRIMARY ELECTION RESULTS

WHEREAS, the PRIMARY ELECTION was held as prescribed by law on June 4, 2024, and;

WHEREAS, the Board of Supervisors have canvassed the vote of said election in accordance with §43.49 and §50.24 of the Code of Iowa, now therefore;

WHEREAS, in accordance with §50.22 of the Code of Iowa, the Commissioner announced there were zero (0) provisional ballots.

BE IT HEREBY RESOLVED that we, the undersigned members of the Board of Supervisors of Poweshiek County, Iowa, do hereby certify the following turnout report and results in the Primary Election, held June 4, 2024, and that no obvious clerical errors were identified during the canvass.

Seven hundred eighty-six (786) people voted at the polls on election day.

One hundred eighty-five (185) absentee ballots were accepted for counting.

No provisional ballots were accepted for counting.

A total of Nine hundred seventy-one (971) people voted.

9:30 a.m. Steve Kivi, Deputy Sheriff joined the meeting.

9:30 a.m. Tom Kriegel, Sheriff and Joe Meyer, Jail Administrator met with board. Discussion on a new grant that may be available from the state for emergency alerts. With the grant for every \$75,000 received from the state, the county would need to match \$25,000. The program allows for when CPR is needed in public places to have individuals certified in CPR to receive notifications that there is someone in need. The funds can also be used to

purchase AEDs in public locations. This is still a pilot program. Meyer stated he will reach out with the three counties that are involved in the pilot program.

Discussion was held regarding the radio system and how the pagers and hand-held radios operate with 911 communication and the scan feature of the radios. Sheriff Kriegel indicated if emergency responders are abusing the scan feature, he will remove that feature from that agency. Meyer then indicated there are about 17 channels available to use for emergency responders to communicate with law enforcement.

Roudabush stated he attended a HAZMAT meeting last week and Region 6 meeting yesterday.
