8:35 a.m. Sandy Ross, Treasurer met with board to provide budget information regarding hiring a replacement for an employee that is retiring. Ross provided the board with information showing that she has enough in her budget to hire a replacement on November 1. Ross further stated this individual will be trained in motor vehicle department and then also cross-trained in the tax department. Board reviewed the information and felt it was appropriate for Ross to start the process to hire.

Ross presented the board with information regarding a county held certificate on a mobile home owned by Randall & Connie Lacy at Arbor Lake Mobile Home Park. This certificate was issued in 2022. Ross has been making several attempts to contact the owner to get these taxes paid. The mobile home now seems to be removed from the property and after checking with the City of Grinnell it was found that the utilities were turned off and the meter was pulled on May 14. Ross stated according to Iowa Code, treasurers can put a stop on motor vehicle renewals for unpaid mobile home taxes, which Ross stated had been done. Ross was not sure if the stop could still be in place if the mobile home was removed from the lot. Board advised Ross to check with the county attorney and if allowed, to have the stop remain on the motor vehicle renewals for these owners.

9:00 a.m. Brian Paul, EMA Director met with board to present the 28E Agreement with Northeast Iowa Response Group and have Chair sign. It was moved by Roudabush, 2nd by Tindle to approve 28E Agreement and authorize Chair to sign. 3 ayes. Motion carried.

Board received a request from Pauline Pollock for suspension of property taxes pursuant to Iowa Code Section 427.9. Moved by Tindle, 2nd by Roudabush to approve property tax suspension pursuant to Iowa Code Section 427.9. 3 ayes. Motion carried.

Dawley stated she had a meeting last week at Central Iowa Juvenile Detention Center in Eldora as well as a meeting at Independence Mental Hospital.
