

August 1, 2024

The board met in regular session at 8:30 a.m. Members present Diana Dawley, Jason Roudabush and Jeff Tindle.

Moved by Tindle, 2<sup>nd</sup> by Roudabush to approve agenda. 3 ayes. Motion carried.

Moved by Roudabush, 2<sup>nd</sup> by Tindle to approve July 29, 2024 board minutes. 3 ayes. Motion carried.

8:35 a.m. David-Paul Cavoos, Rural President and Donna Fischer, Director of Development with Unity Point Health – Grinnell Regional Medical Center met with board. Cavoos introduced himself as the new rural president for the facility. Cavoos and Fischer updated the board on current expansion/remodel projects the hospital is completing and hiring a new family practice physician & OBGYN physician. Tindle inquired about the reimbursement on Medicare/Medicaid and Cavoos explained the reimbursement process.

Moved by Tindle, 2<sup>nd</sup> by Roudabush to approve August 2, 2024 payroll for \$316,313.90. 3 ayes. Motion carried.

8:50 a.m. Tanya Michener, ISU Extension joined the meeting. Michener wanted to stop in and introduce herself as the new regional director and to update on the county fair. Michener stated the county fair went well and there were a lot of static exhibits. She also indicated they have hired a new county youth coordinator.

9:00 a.m. Lyle Brehm, Engineer joined the meeting.

9:00 a.m. Scott Steffen met with board to discuss straightening 450<sup>th</sup> Avenue in Guernsey. Steffen provided options of purchasing land for ROW and area for new road work. Brehm stated he pulled accident history for this area and found one within the last ten years and doesn't see data that would constitute revamping the road. Steffen stated there are many unreported accidents there. Dawley inquired on the cost and Brehm stated he didn't have any cost estimates but could state there would need to be right-of-way purchased. Steffen stated if straightening the road is not an option, perhaps there could be some regrading completed. Roudabush inquired if the county could reshape it for better site & grade and if the current owners would be willing to clear out brush for better site distance. Brehm stated he would pursue this.

9:08 a.m. Tom Kriegel, Sheriff joined the meeting.

Board discussed the certificate of appointment for Nathan Anderson with Kriegel. Kriegel had indicated on the certificate an amount that was not within one of the steps in the union contract. Union contract states sheriff may hire or advance an employee above the start rate based on experience and qualifications so Kriegel thought he could determine the rate. Auditor Eilander reached out to Renee VonBokern, who handles the county union matters if it is possible for sheriff to determine an amount that is not one of the steps within the contract. Board will wait to hear back from VonBokern before approving the certificate of appointment.
