9:00 a.m. Opioid committee members Matt Maschmann, Deputy Sheriff; Brooke Holder, Public Health; Missy Eilander, Auditor; Kari Chandler, Asst Finance Director; Bart Klaver, County Attorney met with board to start the process for utilizing the opioid settlement funds. Also to serve on the committee will be Supervisor Dawley. County Attorney Klaver gave the committee and board an overview of how the opioid funds could be spent. Klaver indicated that 75% of the funds must be spent on the core strategies and he provided examples. Everything must be tied back to opioid use. Public Health director Brooke Holder provided ideas, such as naloxone vending machines, education outreach for the schools in the county, training for first responders & health care workers, and possible funding to the JPK to assist with opioid related medical expenses. Auditor Eilander presented a draft of an application for the opioid funds and a quarterly update form. Anyone wishing to request opioid settlement funds will need to use the application, which will be presented to the committee for review to ensure the request meets the guidelines for expensing and then will be delivered to the board of supervisors for final approval. The first deadline date to request funding will be December 31, 2024. Everyone is encouraged to get the word out that the county has these opioid settlement funds available to opioid remediation for residents of Poweshiek County.

Tindle stated he attended the Middle Iowa Watershed Management Authority meeting last week and he has the conservation meeting this week.

Dawley stated she attended the Central Iowa Juvenile Detention meeting last week.
