9:00 a.m. Tom Kriegel, Sheriff, and Matt Maschmann, Deputy Sheriff (incoming Sheriff) met with the board for a departmental quarterly update. Kriegel stated he has been working with Maschmann to help transition him into the role of Sheriff come the new year. Matt Wray starts next week as deputy sheriff and will be going through the FTO program until he attends the law enforcement academy in May. Maschmann stated he is starting the hiring process for another deputy due to the retirement of a current deputy. The application process will be open from December 16 to January 17 and testing and interviews for non-certified applicants will be held on January 25. Maschmann stated he is going to try some new recruiting options in hopes of getting more applicants. The sheriff's office has three dispatchers going through training and hopes to have another individual to start as a dispatcher after the first of the year.

Maschmann discussed a meeting he had with State of Iowa regarding the gates at the on-ramps of I-80 and their procedure for closure of the gates and access to I-80. Maschmann stated the State is updating the plan due to comments received from this meeting. A lot of questions needing answers were those such as how will emergency personnel get access to I-80 if gates are closed; who is responding to the accidents on I-80; how will this affect the county and outlying state highways; access to hotels and just a lot of questions that yet need answers for the sheriffs and EMA's within this I-80 corridor.

Dawley asked Maschmann if he still intends to utilize Opioid funds for training at school. Maschmann stated organizing of this training is underway.

9:30 a.m. Scott Steffen and Roger Steffen met with the board to discuss a parcel located in Guernsey that lies between a parcel owned by Steffen and a parcel owned by Grier. It was found by the Auditor's Office Real Estate Assistant that there was a parcel of land owned by Steffen and a parcel of land owned by Grier. There was a survey completed on each of these parcels and after said survey, Steffens conveyed to Poweshiek County Lot A in Lot 8 in Lot 2 and Griers conveyed to Poweshiek County Lot A in Lot 9 in Lot 2. Poweshiek County then conveyed Lot A in Lot 9 in Lot 2 back to Griers but no transfer was done with Lot A in Lot 8 in Lot 2, which Poweshiek County received from Steffens.

Steffens stated back in 1982 the intent was for Poweshiek County to build a maintenance shop on this land but that fell through so the intent was to convey those parcels back to the original owners, Grier and Steffen. Steffen stated he was advised by the county that this had been taken care of so was not aware that this parcel was still in the county's name until found by the Auditor's Office. Steffens further stated that at that time Poweshiek County Conservation owned the park across the road and the county then built a shop on that land. That land was later conveyed to the City of Guernsey with an agreement that the county could house a maintainer in that building. This has been the agreement since. Steffen stated this parcel should be transferred back to them and the county agrees. The county will work with the county attorney to get the property transferred.

Steffens thanked the board for working with them on this parcel of land and for working on ways to improve the road going through Guernsey on the east side.

10:00 a.m. Lyle Brehm, Engineer met with board to present a revised county five-year program resolution for the board to sign. The resolution is revised for the following: The bridge in Deep River Township was originally estimated at \$750,000. The new estimate is \$1,135,000. The bridge will be paid for with federal funds. Whenever the estimate increases by more than 15% of the programmed amount, it is necessary to update the programmed amount.

The resurfacing on Old 6 from IA21 into Victor includes work both inside and outside of Victor. Poweshiek County is obviously responsible for paying for all work outside of city limits. While Victor is responsible for costs inside city limits, Poweshiek County has a policy to pay for ½ of the road related expenses of a Farm to Market Extension within the city limits. Poweshiek County will pay for the project out of our Farm to Market funds and the City will reimburse the county appropriately. The total estimated cost of the project is about \$2,000,000. Poweshiek County is going to receive \$1,200,000 of federal funding for the project. City of Victor secured \$225,000 for the work within city limits (their total liability is estimated at about \$350,000). The original programming for this work caused two separate projects to be created. For the ease of funding through IDOT Brehm is trying to put the City's funds together with our funds. That is the second change.

Brehm also presented to the board for signature road plans for Old 6 Road from Hwy 21 into City of Victor and road plans for 480th Avenue from Hwy 63 to Lake Ponderosa.
